Invitation to Tender for hiring of security guards at Chancery and India House, Suva

Scope of Work

High Commission of India, Suva invites proposal for hiring of security guards at Chancery (Level 5, LICI Building, Butt Street, Suva) and at India House (72 Princess Road, Suva) from the companies having experience of working in this sector. Requirement of security guards is mentioned below:

Location	Required number of guards	Required shift
Chancery	1	From 09.00 AM to 06.00 PM on Working Days
India House	2 (Round the clock)	3 Shifts of 8 hours each for all days

Eligibility Criteria

The following eligibility criteria are required to be met for participating in bidding process:

Criteria for the Company:

- i The Company should be registered for doing such jobs in Fiji for more than 6 years as on 01 June 2025. Certificate of Registration of Company as per Form A5 needs to be submitted along with the technical bid.
- ii TIN and VAT registration letter issued in the name of company needs to be submitted along with the technical bid.
- The Company should have experience of undertaking similar works in recent past for more than last six years as on 01 June 2025 and should provide details thereof. A copy of similar works certificates needs to be submitted along the technical bid.
- iv The Company should be competent enough to begin the work as soon as job is awarded.
- v The Company should not have been barred/black-listed by the Government authorities in India, Fiji or elsewhere.

- vi The Company should have enough logistics to supervise the deployed security guards periodically and also to address any urgent call.
- vii List of guards in the Company along with details of security license and their age duly vetted by Ministry of Defence, Government of Fiji needs to be submitted along with the technical bid.
- viii A Certificate regarding 02 years validity of Tender documents including financial bid needs to be submitted along with the technical bid.

Criteria/Guidelines for the security guards:

- i Age of security guards to be deployed should not be more than 50 years.
- ii Security guards should be physically and mentally fit. He/She should not suffer from an apparent disability including obesity/overweight. The Guard should not be emaciated, feeble and timid in an apparent sense.
- Security guards should be should have been vetted by local government's security department(s) in terms of past record, character and antecedents. A certificate to this effect needs to be submitted along with the technical bid.
- iv Security guards should be in appropriate uniforms and their overall appearance should be neat and clean.
- Security guards should possess training in basic security duties such as access control and anti-sabotage checks (of person, baggage and vehicles) including the use of basic security tools such as HHMD, CCTV system, baggage scanners, etc.
- vi Security guards should have the working knowledge of English/Hindi/itaukei.
- vii Security guards should know how to react in case of fire, medical and other emergencies.
- viii Place of duty should not be left unattended at any point of time. Where guards are required in shift duty, no security guard would be allowed to leave the duty until his/her replacement arrives.

Submission of Bids

The Companies are requested to submit their proposals in two separate parts (in two separate sealed envelopes) as follows:

Technical Bid: Technical Bid should consist of the details of services along with terms and conditions. This should also include the check-list and documentary proofs for fulfillment of the above-mentioned eligibility criteria.

- ii Financial Bid: Financial Bid should indicate service-wise price (including public holiday) for the services mentioned in technical bid and should be valid for two years, as per Annexure I.
- Proposals as described above, should be submitted to the High Commission of India, Suva (Administration Division, Level 5, LICI Building, Butt Street, Suva, Fiji) by 5.30 pm on 04th July 2025.

Evaluation of Bids and Award of Job

The High Commission would examine the technical bids in light of the security and technical parameters set by Government of India. Those who qualify the technical evaluation will only be considered for financial bid.

2. Job will be awarded on the basis of Quality and Cost Based Selection. Once the job is awarded, the selected company shall need to enter into an Agreement with the High Commission of India, Suva in terms of security and sensitivity involved in the job. After commencement of services, monthly invoices should be submitted to the High Commission and payment will be made on monthly basis. The initial agreement will be signed for minimum two years which may be renewed further on mutual understanding. Therefore, the quoted rates must remain same for the next two years subject to revision of minimum wages as revised by the local government.
