

After coming back to India, he worked for youth with his teachings for an all encompassing society.

He further said that a man is not poor without a rupee, but a man is really poor without a dream and ambition. You are the creator of your own destiny. Swami Vivekananda founded the Ramakrishna Math. a monastic order based on his guru - Ramakrishna Paramhansa \_ teachings in Kolkata and a worldwide spiritual movement known as the Ramakrishna Mission based on the ancient Hindu philosophy of Vedanta.

ndia Post Payments Bank's ambitious scheme 'Aapka Bank Aapke Dwar', which was launched on September 1, 2018, has become a boon for the poor living in rural areas. The number of account lockdown, Rs 1,500 crore was disbursed to around 85 lakh beneficiaries. Due to this bank, Rs 760 crore were paid through 75 lakh Money Orders and Rs 1,100 crore were distributed through DBT. ■



The Scheme| Anyone from the rural area can avail the bank facility from the local post office through Aadhaar card. One can call the postman by sending a phone message. India Post Payments Bank is available in more than 1.36 lakh post offices across the country. ■

## 1.22 CR KCC SANCTIONED; Rs 1.5 LAKH CR Credit Provided Under ECLGS

n an effort to buffer the agricultural sector from the shock of COVID-19, a special saturation drive is underway to provide concessional credit



to farmers through Kisan Credit Card (KCC). As on August 17, 2020, 1.22 crore KCCs have been sanctioned with credit limit of Rs 1.02 lakh crore. This will go a long way in reviving the rural economy and accelerating the agricultural growth. Providing credit to different sectors, especially MSMEs, under the 100% Emergency Credit Line Guarantee Scheme (ECLGS). Banks from Public & Private Sectors have sanctioned

loans worth over Rs 1.5 lakh crore as on August 18, 2020, of which more than Rs 1 lakh crore have already been disbursed. ■

## PORTABLE HOSPITAL medicab in two hours



Corona pandemic has set many examples of how crises can be turned into opportunities; a portable hospital mediCAB is one such example. This microstructure can be set up in two hours at any geographical location of the country that can withstand any weather and situation. *Sree Chitra Tirunal Institute* for Medical Sciences and Technology, Thiruvananthapuram and IIT Madras have jointly developed this to fight against Corona. A 30-bedded mediCAB hospital in Chengalpattu in Chennai and 12-bedded in Wayanad in Kerala are already functional. ■



# **B.R.O. CONSTRUCTS BRIDGE IN 20 DAYS**

ringing relief to about 15,000 D people of 20 villages from Jauljibi to Munsiyari in Pithoragarh district of Uttarakhand, Border Roads Organisation (BRO) has achieved a feat of constructing a 180-feet bailey bridge in the sector in less than three weeks despite frequent landslides and heavy rains. The 50-metre long concrete bridge was washed away on July 27, 2020 due to cloudburst, flooding nallas and rivers. There were many casualties also due to landslides and the road communication was also broken. The BRO mobilised its resources to construct the bridge in 20 days. ■

## Rs 27,655 CR INVESTMENT FOR RAIL Connectivity of North East



Development of North Eastern region has always been the top priority of the Government. The Government invested Rs 27,655

crore on Railway projects between 2014 and 2019 while investment of Rs 10,610 crore was made between 2009 and 2014. Now, the entire North East is connected with the Railway network except Sikkim which will also be connected by December 2022. ■

## USE OF PLASTIC IN J&K ROADS UNDER PMGSY

**C**onnectivity in Union territories of Jammu and Kashmir and Ladakh is not only being augmented but plastic waste is being utilised to



construct roads in the Leh district. To connect unconnected habitations, under Pradhan Mantri Gram Sadak Yojana, (PMGSY), 1,858 roads

of 11,517 km length and 84 bridges have been completed in J&K while in Ladakh, 96 roads of 699 km length and 2 bridges have been completed till July 2020. ■

# **SUCCESSFUL CIVIL SERVICES CANDIDATES HONOURED**



The Government's resolute effort for "promotion and progress" of meritorious youth from minority communities has resulted in selection of 22 youth from poor, weaker, deprived sections of minority communities in the prestigious civil services with the assistance of free coaching under "Nai Udaan" scheme, being run by the Ministry of Minority Affairs. # LET'S HONOUR 'DATA WARRIORS'

Data plays a vital role in the country's economy and policy making. Data collection is a herculean task where the onus is on those who collect data from the remotest areas of the country. These 'Data warriors' provide accurate data to the Government and in the times of pandemic, they are playing a crucial role in providing correct information so that the motto of the National Sample Survey's 'Right Data, Right Development' could be realized



ou must have heard about the sanitation warrior who helps in removing dirt. You must have also heard about a Corona warrior fighting India's war against an epidemic like COVID-19. But there is also a warrior who works hard to collect data related to the Sustainable Development Goals (SDGs) with various parameters of schemes for poor, employment, inflation, health and economy from the ground, braving adverse climatic conditions. Now. the question arises that who will use these figures and for what?

These data warriors belong to National Sample Survey (NSS). They collect data related to the schemes and policies through which the government reaches to the public. During Corona pandemic about 6 lakh field officers are engaged in data collection. The data is recorded electronically through APP based technology for a faster analysis.

#### WHY DATA IS IMPORTANT

The importance of data can be understood by the words of the famous statistician of the USA, William Edward Deming, "Without data you are just another person with an opinion."

the basis Data is for strengthening any idea. How much the rural-urban population spends on everything from industry, market, education, health, food and living to every other thing are important. Data plays a crucial role in policy formulations. Thus, figures have to be accurate for the viability of any scheme of the Government.

According to NSS Director General A K Sadhu, "From time to time, the Government conducts surveys on topics like agriculture, consumer price index, domestic cow, market prices, production, inflation, health, etc., for which we

collect data. In doing this, our employees sometimes have to climb mountain and sometimes have to cross rivers. After the process of data collection is over, a report is prepared on its basis. This report is used by the Government in policy making. For making a pragmatic project or scheme, it is mandatory that data should be accurate."

#### DATA COLLECTION IS NOT AN EASY WORK

There is always a detailed study and foundation behind any policy formulation. For instance, if there is a scope for development in terms of infrastructure like roads. healthcare and other things in a particular region, the accuracy of that region's data is crucial for the Government to proceed further. But collecting data is not an easy task. Many a times, they have to reach the village or the remotest tribal areas by foot.

## **Essence of poetic expression of a Data Warrior**

Data is the basis of all decision making and more so when it comes to any matter of Government. It had to ensure that the data collection continues in a smooth manner and without any hindrance despite the pandemic situation. It is here where the Data Collectors now turned to Data Warriors. Not fearing their lives, and with due precautions as advised by the Health department, they ensured they would continue to collect the facts and figures in order that the Government may get details on Industrial Production, inflation, employment etc.

with this work describes his experience while conducting surveys in Andaman and Nicobar, "There were small islands selected for surveys.

It was challenging to conduct a survey there. Our data warriors used to reach various Islands by using ships and small boats. They used to stay there in challenging conditions but did their job very efficiently. There are risks as people may be harsh to their surveyors." The work on the Multiple Indicator Survey is currently going on which is to be completed by December, 2020. Arrount 6 lakh data warriors are engaged in reaching out to about 23 crore families.

# SWACHH SURVEKSHAN A PROMISE OF 'CLEAN INDIA'

Mahatma Gandhi said that cleanliness should become a habit for every individual. So, adopting the motto of the Father of the Nation, every city of the country is vying to get a respectable position in the Swachh Survekshan (Cleanliness Survey) to realize the vision of Prime Minister Narendra Modi's clean India



hen Prime Minister Narendra Modi launched Swachh Bharat Mission five years ago, he exhorted people of the country to come together to realize the goal of this campaign. Needless to say that *Swachh Survekshan* has created a positive impact on people's health, livelihood, quality of life and has most importantly brought change in their thoughts and behaviour.

The 5th edition of Swachh Survekshan under the Ministry of Housing and Urban Affairs (MoHUA) has been conducted to assess the progress of Swachh Bharat Mission. Indore has won the coveted title of being the cleanest city of India, Surat and Navi Mumbai have won the second and third position, respectively (in more than 1 lakh population category). Chhattisgarh has won the prestigious title of the cleanest state in the Urban Local Bodies (ULB) category while Jharkhand has been adjudged as the cleanest state of India (in the <100 ULB category). An additional 117 awards have also been handed over by the Minister of State for Housing and Urban Affairs Hardeep S Puri on August 20, 2020.

# Indore's consistent performance

The city has implemented door-to-door garbage collection system at the primary level. There are 10 garbage stations to dispose of 100 per cent waste every day



- Segregation of Waste: Segregation of 18 types of wastes like wet, dry, domestic, contagious etc
- Cleaning Through Machines: Machines are being used for the cleaning of the roads on daily basis for the last two years
- Compost From Domestic Waste: Indore is the first city to start this and 45,000 homes in the city are making compost from domestic waste
- Waste Transportation: Collected waste brought to the waste centre through

The Survekshan has gradually evolved from being an assessment of 73 cities in 2016 to an evaluation of 4.242 cities in 2020. As a part of Swachh Survekshan 2020, to encourage extra efforts put in by citizens and ULBs, 'Innovation and Best Practices' in the areas like waste management, behaviour change, sustainable sanitation or interventions contributing to proven improvement in air quality, water conservation, waste water treatment and its reuse or storm water management were evaluated separately.

Around 3,010 ULBs submitted the innovative

- Public Toilet: There is a facility of toilets in every public place of the city. People are penalised for spitting and littering by the local civic body
- Plastic- Free City: There is a ban on disposal of waste. The city has started free utensils bank. There is ban on use of plastic bags
- Water Treatment: Recycled dirty water is being used for aardening and construction work through pipelines
- **Earnings From Waste:** Local civic body makes compost from the waste and has started selling it for Rs 2 per kg to farmers.

# 'Plastic-free' Gandhinagar

Gandhinagar, the capital city of Gujarat, aims to be a zero landfill city. Under the "Plastic-Free Gandhinagar Initiative", Gandhinagar Municipal Corporation (GMC) has taken several measures

to reduce, reuse, recycle and safely dispose of the plastic waste. It collects segregated dry and wet waste from door-to-door collection activity. A plethora of this is plastic

waste. The GMC has also initiated the process of creating a sustainable ecosystem wherein informal waste pickers and the company can collaborate to efficiently manage the plastic waste in the city.

# **Raipur: 'Shame by Fame'**

'Afsaro Ki Gashti' and 'Shame By Fame' are two novel ideas, easily implementable, sustainable and scalable. 'Afsaro Ki Gashti' is an innovative cleanliness drive which supports the behaviour



changes of the citizens of Raipur, the capital of Chhattisgarh. In this effort, all higher officers are supposed to visit in the morning by

6 AM and verify whether sanitation activities are performed satisfactorily or not. 'Shame By Fame' is an innovation to monitor offenders who create nuisance through a monitoring system called "DAKSHA".

# Greater Chennai: From waste to compost



The Greater Chennai Corporation has evolved a unique idea of converting waste into compost. It has Resource Recovery Centers (RRC) and Micro Compost Centers (MCC) in all 15 zones across Chennai. The RRCs perform segregation of waste collected from the households and markets of respective zones. There are around ten to fifteen categories of segregation depending upon waste produced in these zones. The MCCs produce compost from the wet waste.

Speaking about the genesis of what has become the world's largest urban sanitation survey, Hardeep Puri said, "When the Swachh Bharat Mission – Urban (SBM-U) was launched in 2014, it was with the objective of making urban India 100 per cent ODF along with 100 per cent scientific solid waste management. With no concept of ODF in urban areas and solid waste processing standing at a mere 18 per cent, it was clear that an accelerated approach was necessary if the Prime Minister's dream of a Swachh India was to be realised within the timeframe of five years. A framework was, therefore, needed to bring about rigour in the progress in monitoring and a spirit of healthy competition amongst states and cities to improve their performance in key cleanliness parameters. It was this underlying thought that led to the conceptualization and subsequent implementation of Swachh Survekshan."

# **Ayushman Bharat:** Saving millions of lives

The Prime Minister's ambitious scheme Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (PMJAY) has become a major lifesaver for poor families with the number of beneficiaries crossing 1 crore mark and becoming a saviour during COVID-19 pandemic

yushman Bharat – Pradhan Mantri Jan Arogya Yojana (PMJAY), and Health & Wellness Centre – the world's largest fully government-funded health insurance scheme is proving to be a boon for the poor with the number of beneficiaries over 1 crore.

The objective behind the launch of PMJAY has been to help reducing the massive expenditure on hospitalizations, which pushes 6 crore people into poverty every year, and will help mitigating the financial risk arising out of traumatic health conditions in these families.

While speaking from the Red Fort on August 15, 2018, the Prime Minister announced the launch of the world's biggest healthcare scheme. Later on September 23, 2018, true to his working style, he launched the scheme as PMJAY.

As the Prime Minister has utmost concern for the uplift of poor, the hallmark of this scheme is that it provides health cover of Rs 5 lakh per family per year for secondary and tertiary level healthcare through hospitalization. The scheme reaches to over 10.7 Crore poor and vulnerable families i.e. more than 50 crore targetted beneficiaries. There is no cap on the family size under the scheme.

During the COVID-19 pandemic, the success of country's public health system particularly in the rural hinterland was reflected through continued operationalization of the Ayushman Wellness Bharat Health and Centers continued (AB-HWCs) and delivery of non-COVID essential health services while meeting the urgent task of prevention and management of COVID-19.

An additional 13,657 HWCs were operationalized between January and July 2020 which ensured that an array of healthcare reaches the vast community of citizens they serve. As on July 24, 2020, a total of 43,022 HWCs are operational across the country.


In the month of July, 2020, a total of 44.26 lakh people were benefitted from the health and wellness services being provided by the AB-HWCs. The cumulative footfall in the HWCs since their inception on April 14, 2018 rose to 1,923.93 lakhs. This is a testimony to the foundational work of the HWCs. They have played a pivotal role in ensuring that non-COVID essential services are not hampered.

#### **Key Features of PMJAY**

- PMJAY provides cover to Rs 5 lakh per family per year for secondary and tertiary care hospitalization across public and private empanelled hospitals in India
- Over 10.74 crores poor and vulnerable entitled families (approximately 50 crore beneficiaries) are eligible for these benefits
- It provides cashless access to healthcare services (indoor) for the beneficiary at the the hospital

If the poor had to pay for the treatment post hospitalization, had they not received free treatment, according to a rough estimate, more than Rs 14,000 crore would have been required to be paid out of their own pockets. The 'Ayushman Bharat' scheme has saved spending this huge amount of money belonging to the poor. I congratulate not only the beneficiaries of 'Ayushman Bharat' but also all the doctors, nurses and medical staff who treated patients under this scheme. 

aji Abdul Aleem, heading a family of eight, was suffering from chest pain for over three years. He was told to undergo a bypass surgery to remove clot from his blocked arteries after further checkup. The high cost of surgery was a nightmare for the family which was unable to meet their daily needs due to poor financial condition. Day by day his misery was increasing as there was an increasing risk of heart failure if surgery was not performed soon. With the help of one of the IEC programs by the State Government on Ayushman Bharat scheme in Varanasi, the family got to know about the criteria and various benefits of the scheme. Haji visited the nearest centre with necessary documents and received his golden card. His family brought him to Lucknow for surgery where he got operated for open heart surgery.

## **PMJAY: A BLESSING FOR SONI**

Soni was suffering from heart disease in which one of the valves in her heart required replacement. The family of 10 was hardly able to make both ends meet through daily wages from the labour job of Soni's husband.

Even after such financial hardships, Soni's husband Kahtoon managed to get loan of around Rs 2.5 lakh for

her treatment in a private hospital in Bihar. However, this treatment was unable to help Soni and she was in same pain as before. Fear of losing her life due to lack of proper treatment and the fact that



her children would have no one to look after had been a continuous trauma for her.

Finally, when they were referred to a multispeciality hospital in Uttar Pradesh, they found a great support in terms of Ayushman Bharat PMJAY. Being an eligible beneficiary under this scheme, she underwent a surgery for replacement of heart valve there. Soni is now completely recovered and back with her family and children. The scheme turned out to be a blessing for her through which she was able to save herself and future of her children.■

ONLY FEASIBLE SCHEMES

#### What is sports Ministry doing to support sportspersons in their preparations during COVID 19 pandemic?

When the pandemic hit the world, sporting events were the worst affected. But we have found out certain ways to engage our sportspersons. L started online physical activities monitoring system through their coaches. To continue with their fitness regimen, athletes are following well-designed activity suitable physical to their respective sporting discipline. There is SOP for sports involving more than two sportspersons.

#### Are Indian sportspersons prepared for Tokyo Olympics, if any call is taken?

Our athletes are well prepared but when events like the Olympics come up, one has to prepare on a different note. Now, preparations have started once again and it will reach its peak next year by July and August.

# • Tell us something about sports infrastructure getting augmented in India?

Sports infrastructure is the basic requirement for athletes to excel in their respective sporting disciplines. We are giving the best facilities at national camps including paying as high salaries as Rs 10 lakh per month to foreign coaches. The Prime Minister has been kind enough that we have got better allocations giving good leverage to take care of our financial requirements.

#### There are many talents in the remote areas of the country, what are the plans of the Ministry for them?

We are a country of 130 billion people but we are hardly able to win one or two medals. Now, we are targeting young talents between 8 and 12 years of age group by dividing the country in five zones. Five talent scouting committees will be constituted which will seek help from former players, experts and knowledgeable personalities region wise. Every sports will have a separate committee. They will be identified and admitted in the National Sports Academy in the junior Several category. other measures have also been taken. On this basis. I can say that we will 10 be among the top countries in the 2028 Los Angeles Olympics.

# What is your message for sportspersons as a Minister?

There is no sporting culture in the country despite the fact that there is no dearth of talent. The mindset has been that there is no future in sports. Change is possible only if society gives it a recognition. We have started a fund in the name of Deendayal Upadhyay under which sportspersons, who had played for the country, are being provided with assistance up to maximum of Rs 10 lakh. ■ Industry




# **TOY INDUSTRY'S HUGE** POTENTIAL FOR **GROWTH**

# Fight to finish

#### Recovery rate of Corona patients reaches over 77 per cent with an efficient 'test, track, treat' strategy adopted by the Government

f 110-year-old Siddamma from Chitradurga district in Karnataka got discharged from hospital on August 1, 2020 after getting admitted to hospital on July 27, 2020, then there is 103-year-old Pareed from Kerala who defeated Corona in 20 days after being hospitalised on July 20, 2020. These are some of the positive stories about some high risk category people emerging victorious in the war against Corona.

With 'test, track, treat' strategy adopted by the Government, the rate of recovery of the Corona patients is gradually getting better and better and the death rate is declining fast. In the past five months, over three-fourths of corona patients got cured and as per data released on September 4, 2020 less than one-fourth cases are active. India's recovery rate amongst COVID-19 patients on August 31, 2020 stands at 76.63 per cent with nearly 19.5 lakh (19,48,631) recoveries than the active cases 7,81,975 which are under active medical care. The sustained high recoveries have ensured that the actual caseload of the country viz. the active cases.

Ten states account for a significant chunk of the total cases in the country. The Prime Minister held a review with the chief ministers of these states on August 11, 2020 and the Cabinet Secretary Rajiv Gauba took stock of the situation on August 27, 2020.

States/UT were advised to proactively take steps towards reducing case fatality to less than 1 per cent across all districts focusing on effective containment, contact tracing and surveillance.


Development of Buddhist Circuit will not only

The long-standing cultural, religious, diplomatic, maritime, business and trade relations with these countries are helping India in many ways and vice versa. India is providing all kinds of facilities to Buddhist pilgrims. The Tourism Minister highlighted the decision of the Government to declare Kushinagar Airport as an International Airport which will offer better connectivity to air-travellers resulting in boost in domestic and international tourism and economic development of the region.

"Ministry of Tourism has taken several initiatives for the development and promotion of Buddhist sites in the country," said Prahalad Singh Patel.

There is an ongoing project being carried out at a cost of Rs 10,000 crore to develop Buddhist Circuit in the country which is expected to be completed this year itself. Union Minister for Road Transport & Highways Nitin Gadkari said on October 17, 2018 that the ongoing project to develop the Buddhist Circuit will be completed by 2020.

Some of the important Buddhist destinations like Bodh Gaya, Nalanda and Rajgir in Bihar, Sarnath, Kushinagar, Shravasti in Uttar Pradesh, Dhauli, Udayagiri, Lalitgiri and Ratnagiri in Odisha, Sanchi in Madhya Pradesh and Lumbini & Kapilvastu in Nepal are the places with Buddhist footprints. Buddhist pilgrims and researchers wish to visit these places which is an age-old practice as well.
