2. Forms which are incorrectly filled in or are incomplete in any respect are liable to be rejected. If information furnished is found to be incorrect or deliberately withheld, visa is likely to be refused or cancelled if already given.

3. Please mention clearly the Checkpost of entry into/ exit form India in Column 13. The applicants may choose any one of the following Checkposts:

By Air: Entry: Mumbai / Delhi By Sea: Mumbai

Exit: Mumbai / Delhi / Chennai

By Road: Attari

By Rail: Attrai Railway Station

4. Copy of the form returned with visa should be surrender at the Checkpost of Entry into India.

#### 5. <u>Requirements</u>:

- (a) Passport valid for at least six months and 2 blank visa pages.
- (b) Four photographs (To be affixed on the box provided in the Form)
- (c) Original sworn affidavit from the relatives the applicant intends to visit in India is required.
- (d) Letter of financial guarantee from your bank to the effect that you have sufficient funds to support you for your travel to and stay in India.
- (e) Photocopy of your Resident Alien Card or visa status in USA.
- (f) A letter from travel agency that you have booked your passage to and out of India.
- (g) Personal cheques or credit cards are not accepted.
